Avoid dispersal of dust in the air (i.e., cleaning dusty surfaces with compressed air). Nonsparking tools should be used. Prevent product from entering drains.

6.3 Methods and materials for containment and cleaning up

Methods for Containment Prevent dust cloud. Cover powder spill with plastic sheet or tarp to minimise spreading.

Use personal protective equipment. Take up mechanically and collect in suitable container for disposal. Prevent product from entering drains. Keep in suitable, closed containers for disposal.
